SUBJECT: Research in the Field of Tuberculosis by Dr. Raymond F. Corpe

Dr. Corpe has done wide ranging research in the field of tuberculosis. His first studies in Atypical disease began in 1956 in which Dr. Corpe collaborated with four other members of the medical staff of Battey State Hospital that resulted in a paper entitled, "Limited Clinical Pathologic and Epidemiologic Study of Patients with Pulmonary Lesions Associated with Atypical Acid-Fast Bacilli in the Sputum". This was presented before the medical section as part of Section 1A at the annual meeting of the National Tuberculosis Association in New York on May 21, 1956. The paper was subsequently published in the American Review of Tuberculosis and Pulmonary Diseases, Volume 75, No. 2 in February, 1957. Further work in the atypical area was conducted in 1963 when Dr. Corpe as a member of the Sub-Committee on Unclassified Mycobacteria of the Committee on Therapy of the American Thoracic Society published a paper entitled, "Status of Disease Due to Unclassified Mycobacteria", which was published in the American Review of Respiratory Diseases, Volume 87, No. 3, (Part 1 of two parts), dated March, 1963

In 1975 at the American Lung Association Meeting in Montreal, Quebec, which was held from May 18th through May 21st, Dr. Corpe expanded his observations on patients with pulmonary lesions associated with acid-fast atypical bacilli over a 25 year period. This study refocused attention on many of the same patients researched in the limited study of 1956, plus the long-term survival of such patients.

Doctors Corpe and Stergus collaborated in a study of open-healing of tuberculosis lesions on which a paper was presented before the medical section as part of Section 3A, at the annual meeting of the National Tuberculosis Association, New York, on May 22, 1956. This paper was later published in the American Review of Tuberculosis and Pulmonary Diseases, Volume 75, No. 2, February, 1957. "The Analysis of the Fate of Patients with Open-Negative Syndrome" was conducted by Dr. Corpe and Dr. Blaylock of the staff of Battey State Hospital and was presented before the medical section as part of Section 5B at the Annual Meeting of the American Thoracic Society in Cincinnati, Ohio, on May 23, 1961. This analysis was subsequently written up in the American Review of Respiratory Diseases, Volume 85, No. 6, In June, 1962.
